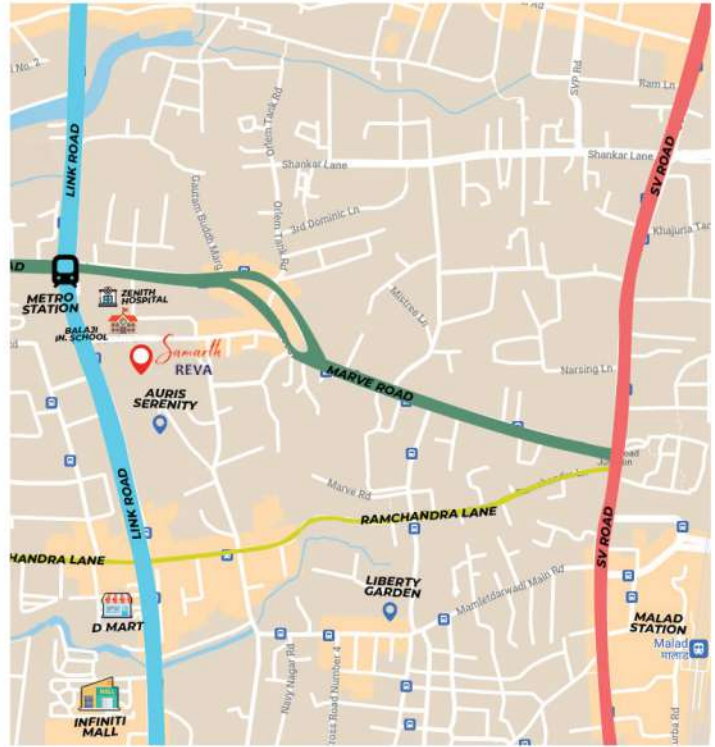


## TYPICAL FLOOR PLAN
